**Ohio's Chief Election Officer.** The Secretary of State oversees all 88 county Boards of Elections in the State of Ohio. The Secretary of State supervises the administration of the Election Laws, approves ballot language, prescribes forms for voter registration and campaign finance, conducts training of elections officials, and canvasses votes for all statewide elective offices. The **Elections Division** compiles and maintains election statistics, political party records and other campaign related materials. Campaign finance reports for statewide candidates are filed with this office. In addition the Secretary of State has a **Business Services Division** which receives and approves articles of incorporation for Ohio corporations and grants licenses to out-of-state corporations seeking to do business in Ohio. The **Corporations Section** of the Business Services Division approves amendments to filed documents, mergers, consolidations, and dissolutions, registers trade marks, and maintains a list of corporations. There are numerous publications available to the public at no charge. **In addition**, The Secretary of State also licenses ministers to perform marriages and issues apostilles, which are certifications verifying signatures on documents going out of the country. All laws passed by the Ohio General Assembly, municipal charters, and administrative rules adopted by agencies, as well as executive orders issued by the Governor are filed with this office.
